MAYOR REPORT

Mayor Johnson reminded Council of the upcoming Municipal Day at the State Capital sponsored by the Louisiana Municipal Association.

Mayor Johnson gave a brief update on the Louisiana Department of Transportation owned LA-30 and LA-75 Turn Lane Project.

Mayor Johnson gave an update on the two Louisiana DEQ Mandated Projects to run both the Sunshine and Carville Sewer Plants to the River. Mayor explained the details of the partnership with two existing pipelines within the City which will ultimately reduce the total cost of the project by \$750,000.

Mayor Johnson gave a report on the 6th Annual Partnership Tax Service Center which was housed at the Community Center from January – April 17 which consists of 1 employee and 5 volunteers, with 100 hours worked, processed 230 returns with approximately \$311,000 in refunds.

Mayor Johnson official recognized Ms. Toya Brumfield, a Senior at MSA East, on April 13, 2018 was 1 of 6 students recognized by Engineering and Science Department at Louisiana Tech for her exceptional computer skills.

Mayor Johnson gave a brief status report of the Carville Levee Trail Project. On a Motion by Councilwoman Alexander and a Second by Councilman Grace with two absent KTB Properties, LLC's Pay Estimate 1 in the \$18,098.10 was approved for the Carville Levee Trail Project.
