- XI. INTRODUCTION** – A BOND ORDINANCE AUTHORIZING THE ISSUANCE BY THE CITY OF ST. GABRIEL, STATE OF LOUISIANA OF ITS TAXABLE LIMITED TAX BONDS, SERIES 2018, IN AN AMOUNT NOT TO EXCEED THREE MILLION DOLLARS (\$3,000,000), PRESCRIBING THE FORM, TERMS AND CONDITIONS OF SAID BONDS; PROVIDING FOR THE PAYMENT THEREOF; ENTERING INTO CERTAIN OTHER COVENANTS AND AGREEMENTS IN CONNECTION WITH THE SECURITY AND PAYMENT OF SAID BONDS; SELLING SAID BONDS TO THE CLEAN WATER STATE REVOLVING FUND; AUTHORIZING THE EXECUTION OF A LOAN AND PLEDGE AGREEMENT AND OTHER LOAN DOCUMENTS WITH THE LOUISIANA DEPARTMENT OF ENVIRONMENTAL QUALITY; PROVIDING FOR THE DELIVERY OF THE BONDS TO SAID DEPARTMENT; REPEALING A PRIOR ORDINANCE IN CONFLICT HEREWITH AND PROVIDING FOR OTHER MATTERS IN CONNECTION THEREWITH.
